Community Development Block Grant-Employment Incentive Program (CDBG-EIP)	Maximum amount of \$500,000	All general-purpose local governments in the Georgia Mountains Region	Examples: Public water and sewer systems, distribution and/or collection lines, wastewater treatment projects, broadband, and rail spurs. Community Development Block Grant (CDBG)	Maximum of \$1,000,000 for a single activity and \$1,250,000 for multi-activity	All general-purpose local governments in the Georgia Mountains Region	Acquisition of real property; as well as, improvements, construction/rehabilitation of public facilities. Examples: housing rehabilitation & reconstruction, water and sewer facilities, mental health centers, adult learning centers, senior centers	June 1st of each year	www.dca.ga.gov

Immediate Threat & Danger (DCA)	Maximum of \$50,000. 50 % match required.	All local governments in the Georgia Mountains Region	Applications must address an event or situation having a particular urgency and uniqueness that adversely affects a community and its citizens and where other financial resources are not available to meet such needs. Recreational Trails Grants (RTP)	Maximum grant award of \$200,000	All local governments within the Georgia Mountains Region	Construction of new trails, maintenance and restoration of existing trails, rehabilitation of trailhead facilities, acquisition, and assessments for handicap accessibility.	2 year cycle	www.gadnr.org

Downtown Development Revolving Loan Fund (DCA)	Maximum of \$250,000	Municipalities with a population of 100,000 or less, counties with a population of 100,000 or less	Real estate acquisition, development, redevelopment, and new construction.
